BEFORE THE STATE OIL AND GAS BOARD OF ALABAMA

PURSUANT TO A DECISION RENDERED DURING A REGULAR SESSION OF THE STATE OIL AND GAS BOARD OF ALABAMA ON NOVEMBER 12, 1993, THE FOLLOWING ORDER IS HEREBY PROMULGATED:

This cause came on for hearing before the State Oil and Gas Board of Alabama on the Petition of AMOCO PRODUCTION COMPANY, a foreign corporation, authorized to do and doing business in the State of Alabama, requesting the State Oil and Gas Board enter an order extending the temporarily abandoned status for certain coal degasification wells located in the Oak Grove and Brookwood Coal Degasification Fields, Tuscaloosa and Jefferson Counties, Alabama. The State Oil and Gas Board, after receiving and reviewing the evidence, finds that due and proper notice of the hearing of said cause by the Board at this meeting has been given in the manner and form and for the time required by law and the rules and regulations of this Board; that proof of publication of notice and an affidavit of notice by Petitioner are on file with the Board; and that the Board has full jurisdiction of this cause. The Board having heard the evidence of witness and arguments of counsel, and being fully advised in the premises finds:

II.

That the above-described wells have previously been placed in the status of temporarily abandoned wells in accordance with Rule 400-1-3-.06(2) of the <u>State Oil and Gas Board of Alabama Administrative Code</u> for a period of six (6) months and said six (6) month status has expired.

III.

That Amoco Production Company does not currently plan to plug and abandon the above-described coal degasification wells because they have future utility in that some or all of the aforementioned wells may be completed and when completed, some or all of the said wells may be capable of producing occluded natural gas or methane from the Pottsville Coal Interval.

CONCLUSIONS OF LAW

IV.

That granting this petition will prevent waste and protect the coequal and correlative rights of all owners in the drilling units assigned to the above cited wells.

Based on the Findings of Fact set forth hereinabove, IT IS THEREFORE, HEREBY ORDERED, ADJUDGED AND DECREED by the State Oil and Gas Board of Alabama that the Petition is GRANTED. Said Petition is granted to extend the temporarily abandoned status for the above-described coal degasification wells located in the Oak Grove and Brookwood Coal Degasification Fields, Tuscaloosa, and Jefferson Counties, Alabama, for a period of six (6) months from the date of this Order or until the next regular meeting of the Board following the expiration of said six months.
