

Jones Hall, University of Alabama Campus, 420 Hackberry Lane, Tuscaloosa, Alabama, to consider among other items the following petition:

Petition by LAND AND NATURAL RESOURCE DEVELOPMENT, INC., an Alabama corporation, requesting the State Oil and Gas Board to enter an order amending Rule 1 of the Special Field Rules for the Chicken Swamp Branch Oil Field to add the Southeast Quarter of Section 27, Township 18 South, Range 15 West, Pickens County, Alabama, to the field limits of said Field, and approving the Southeast Quarter of the Southeast Quarter of said Section 27 as the permanent production unit for the L.P. McGahey 27-16 No. 1 Well, Permit No. 4064-A.

Requests to continue or oppose a petition should be received by the Board at least two (2) days prior to the hearing. The public should be aware that a petition may be set for hearing on the first day or second day of the hearing or may be continued to another hearing at a later date.
