
**LOCATION MAP**




**TOP OF SMACKOVER STRUCTURE MAP**



The State Oil and Gas Board of Alabama will hold its regular hearing at 10:00 a.m. on Tuesday, November 7, 2017 and Thursday, November 9, 2017, in the Board Room of the State Oil and Gas Board, Walter B. Jones Hall, University of Alabama Campus, 420 Hackberry Lane, Tuscaloosa, Alabama, to consider among other items the following petition:

DOCKET NO. 11-7-17-03

First Amended Petition by SKLAR EXPLORATION COMPANY L.L.C., a Louisiana limited liability company, authorized to do and doing business in the State of Alabama, requesting that the State Oil and Gas Board of Alabama enter an order approving an exceptional location for the proposed replacement well to be designated the Cedar Creek Land & Timber 35-15 No. 1 Well and drilled to a bottom hole location approximately 340 feet from the West line and 718 feet from the South line of a 160-acre production unit in the Brooklyn Field consisting of the Southeast Quarter of Section 35, Township 4 North, Range 12 East, Conecuh County, Alabama. The well will have a surface location of 201 feet from the South line and 450 feet from the West line of said unit. The bottom-hole location is an exception to the well spacing rules set forth in Rule 3 of the Special Field Rules for the Brooklyn Field,

as heretofore established by the Board in Order No. 2011-78, which requires that such a well be located 660 feet from every exterior boundary of a drainage or production unit. The Cedar Creek Land & Timber 35-10 No. 1 Well, which is currently producing from the said production unit as established by Order No. 2011-78, will be shut-in and designated as a shut-in well prior to any production of the proposed Cedar Creek Land & Timber 35-15 No. 1 Well.

Hearings of the State Oil and Gas Board are public hearings, and members of the public are invited to attend and present their position concerning petitions. Requests to continue or oppose a petition should be received by the Board at least two (2) days prior to the hearing. The public should be aware that a petition may be set for hearing on the first day or second day of the hearing or may be continued to another hearing at a later date.
